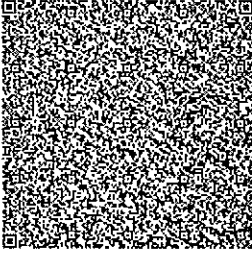

- (2) M/s Docbel Scales, a corporation incorporated under the laws of India, having its principal place of business at 20, Shiv Ganga Industrial Estate, Lakeshwari, Bhagwanpur, Roorkee, Uttarakhand, India and (hereinafter called "the Supplier").

WHEREAS the Purchaser invited bids for Supply of Weighing Balance for Animal Husbandry Clusters under RACP vide IFB No IFB IN-PMU-RACP-37167-GO-RFB and has accepted a Bid by the Supplier for the supply of those Goods and Services in the sum of Rs. 1,28,38,500.00 (In Words: One Crore Twenty Eight Lacs Thirty Eight Thousands Five Hundred only) including transportation & Insurance, excluding all taxes as applicable (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (c) The Supplier's letter of Bid and original completed Schedules including Price Schedules
  - (d) Special Conditions of Contract
  - (e) General Conditions of Contract
  - (f) Technical Requirements (including Schedule of Requirements and Technical Specifications)
  - (g) *Performance Security in form of Bank Guarantee issued by Bank of India, Asaf Ali Road, New Delhi, BG No. 6001IPEBG180004 dated 01.02.2018, amount Rs. 6,41,925/- valid up to 01.03.2018*
3. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.


