

BYE-LAWS

In exercise of the Powers conferred by Clause (F) of Section 22(L) of the Rajasthan Agricultural Produce Market Act, 1961, and all other powers enabling it in this behalf, the Rajasthan State Agricultural Marketing Board hereby makes the following bye-laws for regulating the recruitment and conditions of service of persons appointed to the services of the Board namely :

PART - 1 : GENERAL

1. SHORT TITLE AND APPLICATIONS


- (1) These Bye-laws may be called the Rajasthan State Agricultural Marketing Board (Service) Bye-Laws, 1977 and shall come into force with immediate effect :
- (2) They shall apply to all employees in the service of the Board except those governed by specific agreements:
- (3) Provided that in the case of Government Servants on deputation they shall apply to the extent specified in the terms and conditions of the deputation.
- (4) The posts not reflected in any of the schedule appended to these Bye-laws shall be deemed to open for being filled up by way of deputation.
- (5) All existing rules and orders in relation to matters covered by these Bye-Laws stand superseded, but any action taken by or in pursuance of such existing rules and orders shall be deemed to have taken under these Bye-Laws.


2. IN THESE BYE-LAWS UNLESS THE CONTEXT OTHERWISE REQUIRES

- (a) "Act" means the Rajasthan Agricultural Produce Markets Act 1961.
- (b) "Board" means the Rajasthan State Agriculture Marketing Board, established under Section 22-A.
- (c) "Appointing Authority" means Board and includes in relation to any post in the Service, such other officer who may be especially empowered by the Board to exercise the powers and function of appointing authority.
- (d) "Chairman/Administrator" means the Chairman/Administrator of the Rajasthan State Agriculture Marketing Board ;
- (e) "Direct Recruitment" means an appointment made otherwise by promotion from within the service or by transfer, or deputation of an official already in service of the State Government and includes an appointment made by a method prescribed under these byelaws.
- (f) "Government" means the Rajasthan Government in the Agriculture Department;
