

With the request that

- (a) The list of authorized agents/dealers as submitted to Directorate is made available to the concerned offices.
- (b) In case validity of BIS license expires, may submit the renewed license within two months grace period failing which the registration may be liable for cancellation automatically.
- (c) The details of initial available stock and monthly statement of pipeline supplied to each authorized agent in every district to be sent to Deputy. /Assistance Director of Agriculture (Ext.) of the concerned district. Hence it may be ensured that the cases of financing through subsidy are correlated with the quantum of stocks available with each agent/ dealer.
- (d) For renewal of validity will be disposed by the registering authority once in the last week of the every month. The manufacturer is supposed to submit the renewed BIS license within a grace period of 2 months after the expiry of validity. The registration process will be continuous and open throughout the year.
- (e) The registered manufacturers and their authorized dealers will ensure that the prices/rates charged from farmers for the pipes supplied under subsidy programme and without subsidy in open general sale are similar and reasonable and in case of any discrepancy the registration may be liable for cancellation.
