## CONTRACT AGREEMENT


THIS CONTRACT AGREEMENT is made on... 22.11.2017


BETWEEN

- (1) Rajasthan Agricultural Competitiveness Project and Management Implementation Society (RACPMIS) registered under Rajasthan Society Registration Act, 1958 under the laws of India and having its principal place of business at II Floor, Academic Block, SIAM Campus, Durgapura, Jaipur - 302018, India (hereinafter called "the Purchaser"), and
- (2) M/s New Saggu Agri Industries., a corporation incorporated under the laws of India, having its principal place of business at Sangria Road, Sadulsahar, District- Sri Ganganagar.-335062, India and (hereinafter called "the Supplier").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall constitute the Contract between the Purchaser and the Supplier, and each shall be read and construed as an integral part of the Contract Agreement. This Agreement shall prevail over all other contract documents: In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed below.
  - (a) The letter of Acceptance
  - (b) this Contract Agreement
  - (c) The Supplier's letter of Bid and original completed Schedules including Price Schedules
  - (d) Special Conditions of Contract
  - (e) General Conditions of Contract
  - (f) Technical Requirements (including Schedule of Requirements and Technical Specifications)
  - (g) *Performance Security in form of Bank Guarantee No. 168117IGPER0004 dated 16.11.2017 amount Rs. 4,98,000/- valid up to 15.11.2019 and further extended up to 15.2.2020 on dated 20.11.2017 issued by Andhra Bank, Sri Gangangar*
3. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.


