If successful Bidder is more than one for this variety, the quantity of parental line may be divided between the Bidders, whose Bid is accepted. Splitting of quantity of parental line will be done at the sole discretion of RSSC and the decision of RSSC shall be final and binding on all Bidders and the Bidder who fails to get the opportunity shall not have any right to claim any damages whatsoever against RSSC. All charges, seed cost shall be borne by the bidder.
